RESOURCES SUPPORTED LEGISLATIVE CAMPAIGNING TO STOP A BILL IN THE SENATE THAT WOULD HAVE INCREASED THE COST OF EMERGENCY FOOD AID AND WOULD HAVE RESULTED IN 2 MILLION FEWER PEOPLE RECEIVING THAT AID. OXFAM AMBASSADORS IN 11 STATES TOOK ACTION ASKING THEIR SENATORS NOT TO INCLUDE THE PROVISION IN THE BILL.
